

## New Upgraded Universal Booking Sheet System

### Old

- No password restrictions
- Menu – along the left hand side
- Search for defendants, co-defendants, charges and officers with a search button
- Waiting for Case Number and closing the dialogue box

### New

- Password restrictions to follow FDLE format\*
- Have changed where some menu items are:
  1. Copy Report
  2. View
  3. Print Preview
  4. Delete
  5. Remove Report
  6. Logout (moved to upper right hand corner)
- Search for defendants, co-defendants, charges and officers with a smart search mechanism
- No longer have to close the dialogue box for waiting for case number, will go right to print preview
- Printing is different. It behaves like a browser behaves (see page 16).
- If all three tabs are completed: Administrative, Defendant and Charges, the booking will display in the **DONE** state instead of the OPEN state
